4. The Certificate of Agmark Grading will be issued subject to the following terms and conditions:-

- The approval of the laboratory is valid on date.
- The consignment has been inspected by an approved Chemist of the laboratory.
- The information in the prescribed inspection report provides the complete details of the lot inspected.
- All the requirements prescribed in General Grading and Marking Rules, 1988, Fruit and Vegetable Grading and Marking Rules, 2004 as amended from time to time and instructions issued from time to time are adhered to.
- The authorized packers have deposited the prescribed grading charges.
- The details of Certificate of Agmark Grading issued are sent to concerned office of DMI every week.
